DIRECTOR OF FREIGHT FORWARDING COMPANY FINED \$30,000 FOR CAUSING INCORRECT DECLARATIONS TO BE MADE IN PERMIT APPLICATIONS

Singapore, 11 September 2023 – A male Singaporean, Chong Wei Yoong (张伟荣) ("Chong"), 49, was fined \$30,000 by the State Courts on 8 September 2023 for causing incorrect declarations to be made by a declaring agent in permit applications. Chong had provided commercial documents¹ with an incorrect description of goods for the applications.

2 Chong, the director of ADC Shipping Pte Ltd ("ADC"), a freight forwarding company, pleaded guilty to two charges for causing incorrect declarations to be made in the permit applications. Another four similar charges were taken into consideration during the sentencing.

3 In July 2022, Singapore Customs commenced investigations into ADC after Immigration & Checkpoints Authority officers had found duty-unpaid cigarettes in two containers that the company imported from the United Arab Emirates (UAE) and were declared to contain light-emitting diode (LED) lights. A total of 83,999 cartons of cigarettes found in the two containers were seized.

4 Investigations revealed that Chong was engaged by an unknown person to receive goods imported from the UAE, repack them from the original import containers into new containers, and then make arrangements to ship the goods to the United Kingdom. While Chong suspected that the unknown person might be involved in cigarette smuggling activities, he continued to provide his services to this customer in order to profit from the business deals.

5 Singapore Customs does not condone the use of our port and logistics facilities for transnational smuggling. We will continue to work proactively with our local partner agencies and international counterparts to stamp out such illicit activities.

6 Companies should exercise due diligence to prevent themselves from being exploited by syndicates for illicit activities. They need to ensure that the information they provide for declaration to Singapore Customs is true and complete. Stern actions will be taken against errant traders as we maintain Singapore's reputation as a trusted global trade hub.

Offences and Penalties

7 Under the Customs Act, any person who makes any declaration which is untrue, incorrect or incomplete will be liable on conviction to a fine not exceeding \$10,000, or the equivalent of the amount of the customs duty, excise duty or tax payable, whichever is the greater amount, or to imprisonment for a term not exceeding 12 months, or both.
