3,749 CARTONS AND 3,628 PACKETS OF DUTY-UNPAID CIGARETTES SEIZED AT TUAS AND MARINE PARADE

Singapore, 12 December 2023 – In our ongoing efforts to suppress illegal cigarette activities, Singapore Customs conducted two operations in Tuas Link 3 and Marine Parade Central on 6 December and 7 December 2023 respectively.

2 In the operation conducted at Tuas Link 3, our officers conducted checks on a truck in an industrial unit. They uncovered a total of 1,509 cartons and 3,628 packets of duty-unpaid cigarettes. The truck driver, a 31-year-old male Chinese national, was arrested.

3 In the second operation at Marine Parade Central, our officers uncovered 2,240 cartons of duty-unpaid cigarettes packed in brown carton boxes in a van. A 32-year-old male Singaporean, who was the van driver, was arrested.

4 Along with the duty-unpaid cigarettes, both vehicles involved were also seized during the operations. Investigations revealed that unknown persons allegedly engaged both men to collect and deliver the duty-unpaid cigarettes.

5 The total duty and Goods and Services Tax (GST) evaded amounted to about \$440,127. We have initiated court proceedings against the Chinese national. Investigations are ongoing for the Singaporean. 6 Buying, selling, conveying, delivering, storing, keeping, possessing or dealing with duty-unpaid goods are serious offences under the Customs Act and the GST Act. Offenders can be fined up to 40 times the amount of duty, and GST evaded and/or jailed for up to six years. Vehicles used in committing such offences are also liable to be forfeited.
