SINGAPORE CUSTOMS FOILS REVENUE EVASION OF OVER \$380,000 AND ARRESTS THREE SUSPECTS

Singapore, 6 March 2025 – Singapore Customs (Customs) has successfully disrupted an attempt in distributing duty-unpaid cigarettes, seizing 3,600 cartons of duty-unpaid cigarettes and arresting three individuals. The enforcement actions carried out on 1 March 2025 at Upper Serangoon Road and Segar Road also resulted in the seizure of two vans and \$19,000 in suspected proceeds from the sales of the duty-unpaid cigarettes. The total duty and Goods and Services Tax (GST) evaded amounted to about \$389,944.

As part of our ongoing efforts to combat illicit activities involving duty-unpaid goods, Customs officers conducted an operation at a carpark along Upper Serangoon Road, where they observed two men approaching two vans. Upon inspection, the officers discovered 1,800 cartons of duty-unpaid cigarettes in each vehicle. The two men, both Malaysian nationals aged 36 and 45, were arrested on-site.

In a subsequent operation at Segar Road, a 37-year-old Singaporean man was arrested at his residence. Officers found the \$19,000 in cash - suspected to be proceeds from the sale of duty-unpaid cigarettes - stored in a safe. Preliminary investigations revealed that the two Malaysians allegedly found the job of delivering duty-unpaid cigarettes via social media, and they allegedly received instructions from the Singaporean. Investigations are ongoing.

4 Under the Customs Act and the GST Act, buying, selling, conveying, delivering, storing, keeping, possessing or dealing with duty-unpaid goods are serious offences. Offenders can be fined up to 40 times the amount of duty and GST evaded and/or jailed for up to six years. Vehicles used in committing such offences and proceeds of sales of duty-unpaid cigarettes are also liable to be forfeited.
