# IMPLEMENTATION OF THE REVISED FREE TRADE ZONES (FTZ) REGIME FROM 1 MARCH 2024

With the passing of the Free Trade Zones (Amendment) Bill on 4 Oct 2023, the revised FTZ regime is set to commence on <u>1 March 2024</u>. As part of the enhancements to the FTZ regime, Singapore Customs will introduce a FTZ operator licensing regime and require FTZ cargo handlers and shipping agents to provide information. These are further elaborated below.

# Details of the FTZ Operator licensing regime

2 Currently, the FTZs in Singapore are operated by FTZ authorities. From 1 March 2024, these entities and any other entities seeking to operate any FTZ in Singapore will be required to apply for and obtain FTZ Operator licences issued by Singapore Customs. Applicants must be able to ensure the proper and efficient functioning of the free trade zone and comply with the security and reporting requirements of Singapore Customs. Most of the requirements are not new or are clarifications of existing practices.

3 The application window will be open from 1 March 2024 and more information will be provided through the Customs Website. Customs will also engage the current FTZ authorities to smoothen the transition to the licensing regime.

# Shipping agents to provide information

4 From 1 March 2024, shipping agents will be required to submit information found in the Bill of Lading (BL) to cargo handlers specified in <u>Annex A</u>. Submission requirements and instructions are specified in <u>Annex B</u>.

# FTZ cargo handlers to provide information

5 Specified FTZ cargo handlers will be required to submit information to Singapore Customs, including the information provided to them by shipping agents. Specific details and instructions will be provided via separate notices to the specified FTZ cargo handlers on the date of commencement.

# 6-month Adjustment Period (1 March 2024 – 31 August 2024)

## Containerised Cargo:

6 To allow shipping agents and specified FTZ cargo handlers more time to fully comply with the requirements, Singapore Customs will allow a 6-month adjustment period (1 March 2024 – 31 August 2024) for the industry to make any necessary further adjustments to their work processes for the submission of information on containerised cargo.

7 During the adjustment period, shipping agents and specified FTZ cargo handlers will generally not be penalised by Singapore Customs for non-compliance. This will include late or incomplete submissions. All other customs offences and penalties are still applicable during the adjustment period.

## Non-Containerised Cargo

8 Shipping agents and specified FTZ cargo handlers are exempted from the requirements to submit information on non-containerised cargo until further notice.

## Notice to Air FTZ cargo handlers and air cargo agents

9 Air FTZ cargo handlers and air cargo agents will be temporarily exempted from requirements to provide information. Singapore Customs will engage the air cargo community and relevant stakeholders to explore the setting up of the necessary system linkages and identify industry concerns prior to formalizing any future requirements.

## Form and manner for submission of information on movement of goods

Pursuant to Section 14N of the Free Trade Zones Act, information of goods provided by shipping agents<sup>1</sup> are to be submitted via the appropriate system platforms to specified FTZ Cargo Handlers.

## **Timelines for Submission of Information on Movement of Goods**

3 The paragraphs below specify the timelines for the submission of the prescribed information under the various scenarios:

<sup>&</sup>lt;sup>1</sup>Under Regulation 11(1) of the Free Trade Zones Regulations 2024, the prescribed class of shipping agents is the class of shipping agents of the carriers of the goods concerned.

## Scenario A:

- 4 For imports and transhipment goods entering the listed FTZ(s):
  - a) by sea via vessels; and
  - b) where the voyage duration from the last foreign port to Singapore is longer than 12 hours,

the information provided by shipping agents is to be submitted to the specified cargo handler no later than <u>12 hours</u> prior to the vessel's berthing at Singapore.

#### Scenario B:

- 5 For imports and transhipment goods entering the listed FTZ(s):
  - a) by sea via vessels; and
  - b) where the voyage duration from the last foreign port to Singapore is shorter than 12 hours,

the information provided by shipping agents is to be submitted to the specified cargo handler no later than the vessel's departure from the last foreign port.

#### Scenario C:

6 For export goods exiting the listed FTZ(s) by sea via vessels, the information provided by shipping agents is to be submitted to the specified cargo handler no later than 24 hours after the vessel's departure from Singapore.

## Penalty for non-compliance

7 If any shipping agent, without reasonable excuse, fails to comply with the specified requirements of this circular pertaining to the submission of information under Section 14N(2) of the Act, it shall be guilty of an offence under Section 14N(3) of the Act, and shall be liable on conviction to a fine not exceeding \$10,000 or to imprisonment for a term not exceeding 12 months or to both.
