NO CHANGE TO STATUTORY FEE FOR PERMIT AND CERTIFICATE OF ORIGIN (CO) APPLICATIONS SUBMITTED VIA TRADENET

We refer to the announcement made by CrimsonLogic Pte Ltd (TradeNet operator) on 31 Aug 2022 (refer to **Annex A**) on the adjustment of the processing and messaging fee for permit and Certificate of Origin (CO) applications submitted via TradeNet for processing.

2 We would like to inform you that the statutory fees for the following applications submitted via TradeNet for processing will **remain unchanged**:

- a) \$0.90 per permit application; and
- b) \$4.00 per CO application.

3 With the new processing and messaging fees that will take effect on <u>7 Nov</u> <u>2022</u>, the typical cost of each TradeNet application will be as follows:

a) Each permit application costs about \$3.08 per application, which comprise:

- i) \$0.20 messaging fees (adjusted from the current \$0.18 per application)
- ii) \$1.98 processing fees (adjusted from the current \$1.80 per application)
- iii) \$0.90 statutory fees

b) Each CO application costs about \$6.18 per application, which comprise:

- i) \$0.20 messaging fees (adjusted from the current \$0.18 per application)
- ii) \$1.98 processing fees (adjusted from the current \$1.80 per application)
- iii) \$4.00 statutory fees
- c) Each CO application, together with a Customs export permit application, costs about \$9.06 per application, which comprise:
 - i) \$0.20 messaging fees (adjusted from the current \$0.18 per application)

- ii) Cost of each export permit application:
 - \$1.98 processing fees (adjusted from the current \$1.80 per application)
 - \$0.90 statutory fees
- iii) Cost of each CO application:
 - \$1.98 processing fees (adjusted from the current \$1.80 per application)
 - \$4.00 statutory fees

2 Due to the rising costs of operating and maintaining TradeNet, we would like to inform you of the following new fees which will take effect on **<u>7 Nov 2022</u>**:

- (a) \$0.20 messaging fee (adjusted from the current \$0.18 per application)
- (b) \$1.98 processing fee (adjusted from the current \$1.80 per application)
